5.	<b>Seat Processing</b>	<b>31.01.2022</b>
6.	<b>Result Declaration of Round-1</b>	<b>01.02.2022</b>
7.	<b>Reporting for Round-1</b>	<b>02.02.2022 upto 05:00 P.M of 07.02.2022 (6 Days)</b>

**Candidates are informed as under regarding the above changes:**

1. Registration/ Payment Facility/ Choice Filling is made open for all the candidates.
2. Candidates who are already registered need not register again. Already registered candidates who want to edit their choices can log in to their account, give consent for unlocking their choices and fill their choices again or edit/ modify them.
3. However, Candidates who do not want to edit their locked choices need not do anything. Their earlier exercised choices will be valid for seat processing as such, for Round-1.
4. Candidates who want to do Fresh Registration can do so as per schedule and exercise choices for Round-1 of Counselling after paying requisite fee.
